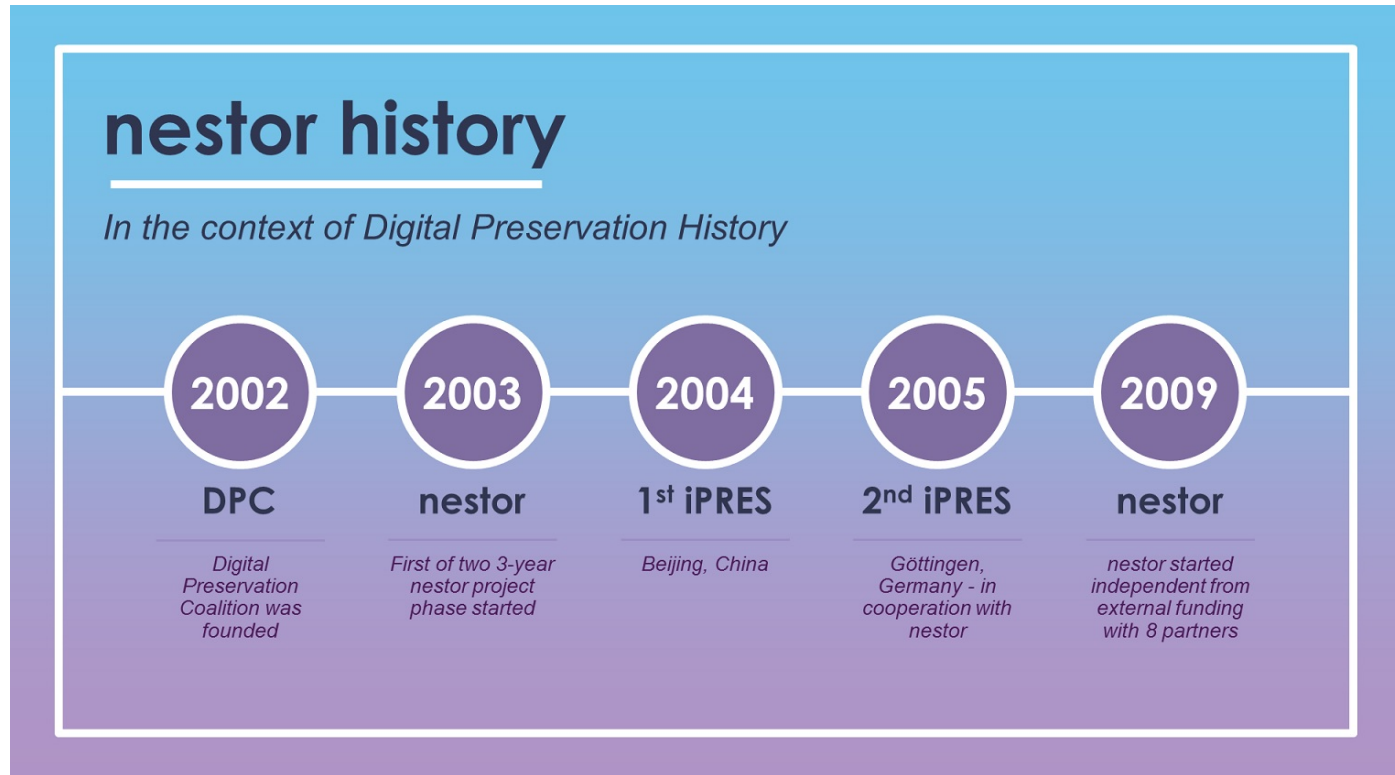

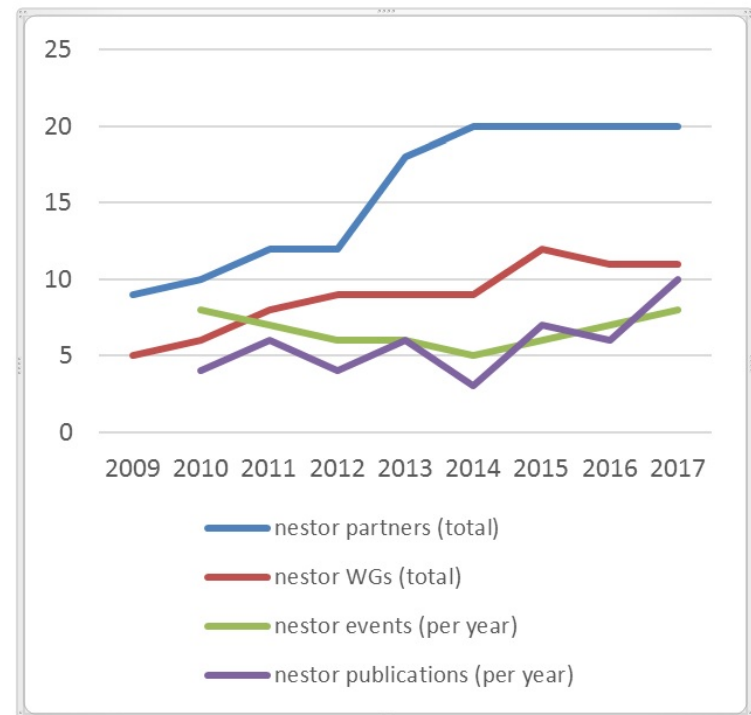
- What is nestor?
 - a German network fostering digital preservation in Germany and beyond ...
 - a network linking libraries, archives, museums ...
 - a network providing support for digital preservation in institutions
 - an open network that is in contact with many global players in the field of digital preservation

nestor's History I - the Past



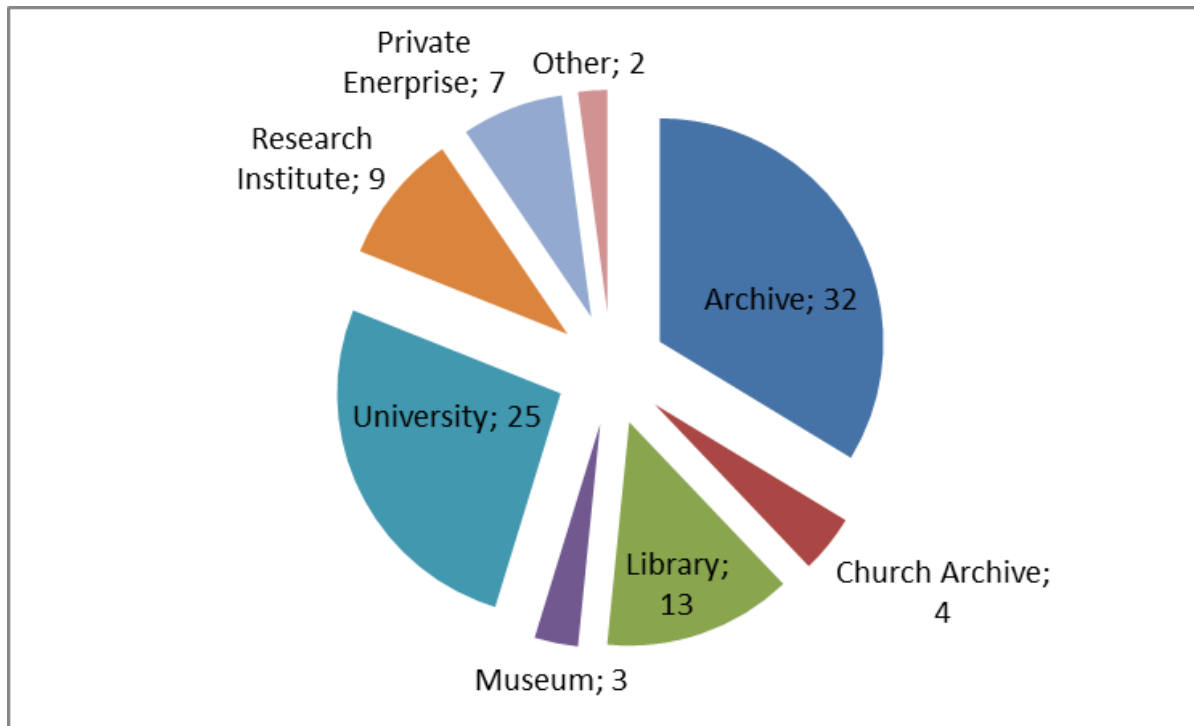
nestor's History II - today I

- 19 partners
- 16 nestor working groups
- 53 events (end of 2017)
- 46 publications (end of 2017)

- 170 persons from 95 institutions are involved
- libraries / archives / museums
- private sector (e. g. PDF Association)

- 400 followers on [Twitter](#)

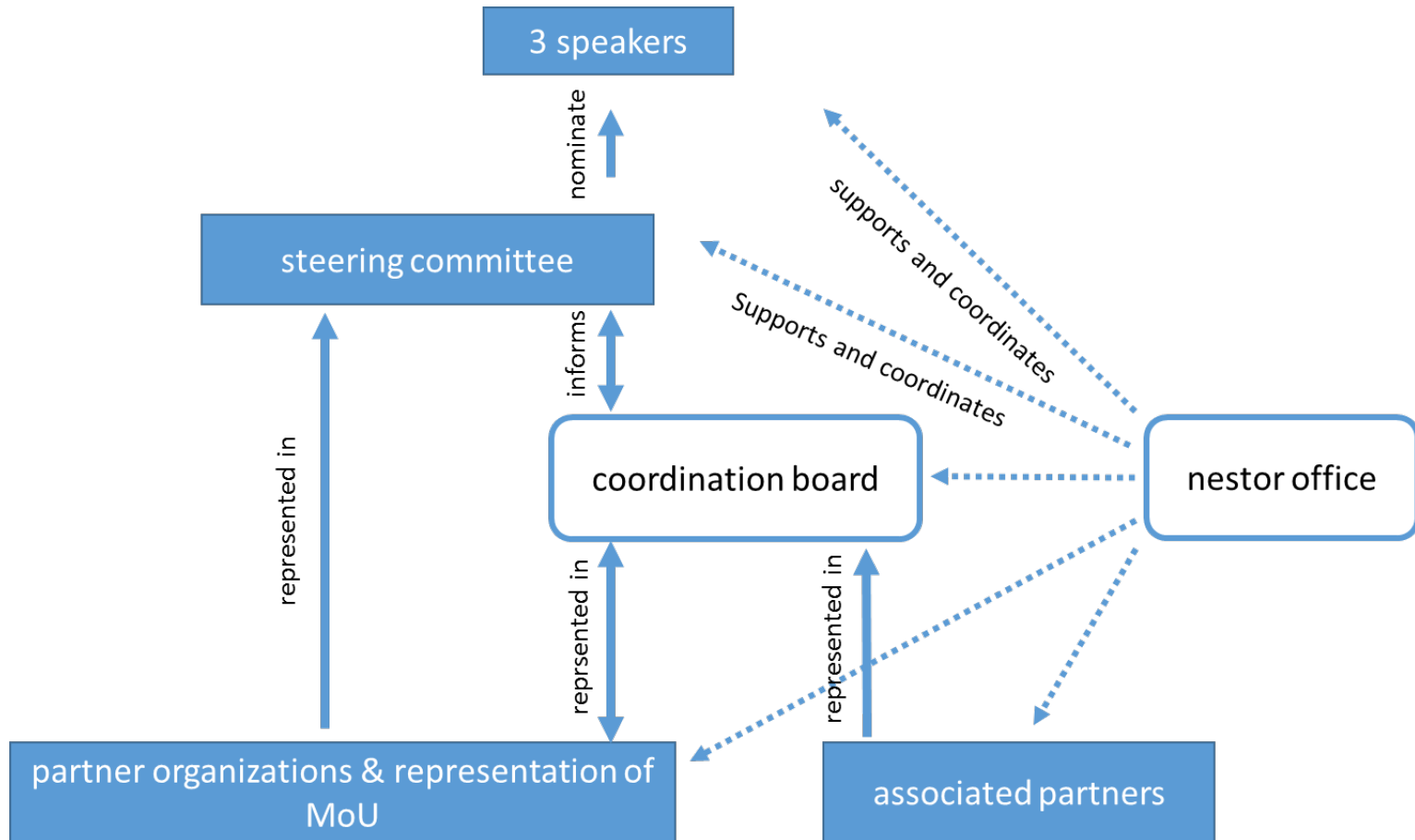


- nestor's Governance Structure I
 - Steering Committee
 - Coordination Board
 - nestor Office (with the DNB in Frankfurt)
 - Working Groups

- The network does not receive any third-party funding, but is maintained by in-kind contributions of its partners and membership fees

- nestor's Governance Structure II
 - steering committee
 - all fundamental decisions concerning nestor
 - nominates the 3 Speakers
 - nestor office
 - coordination and preparation of decisions
 - coordination board
 - coordination of activities and decisions on the operative level

- nestor's Governance Structure IV

- 16 Working Groups

- open for members and many other organisations
 - permanent working groups or temporary ones
 - different topics and different sizes
 - they are at the heart of nestor's activities
 - heads of the groups are members of the coordination committee

■ Key Activities II

- Certification with the nestor Seal
- since 2016
- fits into the EU Framework for Audit and Certification
- Self-assessment process (basis: DIN 31644)
- 34 questions
- so far 4 organisations awarded



Key Activities III

- Events: e. g. nestor Praktikertag
- since 2009
- hosted by one of the 19 partners
- ~100 visitors
- main theme e.g. 2018: PREMIS



■ Key Activities IV

- training e. g. nestor School annually / bi-annually
- 11 higher education institutions signed MoU in 2007
- three days
- one main topic e.g. digital preservation of research data / format migration / digitization

nestor materials	Expertises on special issues and nestor catalogues of criteria
nestor handbook	Brief Encyclopedia on digital long-term-preservation
nestor guide	Brief Guide on preservation of digital resources in museums
nestor edition	Selected scientific papers
nestor checklists	Assistance in the selection of the best system or system components
nestor newsletter	Released several times a year, with news and reports on recent activities
nestor topic	Short articles from day-to-day practice
Infosheets	Various volumes on digital preservation in museums
Reports	Reports on events
Press	Press releases

- ❖ nestor publications e. g. nestor materials
- ❖ 6 out of 22 have translations into English ([link](#))
- ❖ 1 translation into Japanese
- ❖ 1 translation into Dutch



- Key Activities VII

- standardization
- overview over existing standards / own proposals
- collaboration with WG „Records Management and long-term archiving of digital information objects” in DIN Standards Committee Information and Documentation
- preparation of national standardization
- nestor initiated 3 standardization projects

■ Working Groups I

- pick up, bundle and enhance current topics of interest
- work out concepts, handbooks, other information material ...
- main focus on topics interesting for scientific and / or public organizations
- disseminate results (e. g. nestor materials, guides, short papers, lectures on conferences ...)

- Working Groups II

- e. g. Working Group Preservation Policy

- task: fostering of standardised preservation policies

- 12 members

- 24 months work / temporary working group

- results: handbook / blueprint for individual preservation policies of institutions

■ Working Groups III

- e. g. Working Group Certification
- task: developing a concept for trustworthiness and certifying of digital archives / carrying out reviews for the nestor-Seal
- 13 members
- permanent working group since 2004
- results: developing the 34 nestor criteria for trustworthiness / initiating the DIN 31644 / creating the seal and reviewing 4 institutions up to now



- Working Groups IV

- e. g. Working Group Private Digital Archiving
- task: developing information material for private persons who want to preserve their digital assets e.g. for their heirs
- 12 members
- since 2016 / temporary working group
- results (planned): developing a website with information material / presenting these materials in a way that attracts the general public

❖ Lessons learned I

- ❖ communication between librarians and archivists can be difficult
- ❖ different user groups
- ❖ different preservation goals
- ❖ unique material
- ❖ challenge of losing motivation: work is voluntary



❖ Lessons learned II

- ❖ the perspective of a member institution
- ❖ TIB, ZBW and ZB MED are nestor partners
- ❖ It's easier to solve your own problems and to master your own challenges when you're in a strong network
- ❖ work in working groups makes it easier to develop good solutions for yourself e. g. for a preservation policy
